## BIGEFRAME TERMS OF SALE AND LIMITED WARRANTY AGREEMENT

1)Year plus any additional period placed at time of purchase

OPENING THE CASE, CHANGING or ADDING SOFTWARE WITHOUT BIGEFRAME CONSENT WILL VOID THIS WARRANTY. Removing or not using the ground wire and unauthorized case modifications will also void this warranty. Shipping damage will also void the warranty. Bigeframe is not responsible for damages caused during any shipping problems. Please contact your shipper if shipping damage occurs.

- 1. Payment Terms. Advertised prices are in U.S. dollars and exclude shipping, handling, and taxes unless otherwise noted. You are responsible for paying all taxes, sales taxes, country tariffs, and duties associated with your order. You must notify Bigeframe of damaged or missing items from your order within 1 day after you receive your product. Please inform Bigeframe of damaged shipments ASAP so a shipping claim can be placed.
- 2. Return Policy. All sales are final after 30 days of receiving shipment. You may return products for repair within the warranty period if product does not work properly. Please call or email first for diagnosis. Bigeframe will repair or replace product at their discretion. You must pay all shipping costs associated for any repair. Bigeframe will provide a return shipping label with a box and all packing materials. Customer will be billed for the cost of the return shipment, shipping materials, and insurance. If damage was caused by anyone or anything other than part failure, repair cost will be quoted and billed to you and must be paid in full before work begins. Bigeframe is not responsible for any memory cards or USB drives that do not work in digital frame or damage that an improperly memory card or USB drive insertion causes, such as bent pins. Note that all products are tested to be in great working order before they ship. Certain modification fees, shipping costs, and accessories will not be refunded. These exceptions include engraved plaques, shipping, and some custom work.
- 3. Satisfaction Guarantee. If you are not satisfied with your frame you may return it for a refund or exchange within 5 days of receiving frame. Please call or email first. This offer is only valid if the unit is returned in perfect, like new condition within 5 days of the delivery date. All returns up to 25 days after this period are subject to an 18% restocking fee. All sales are final after 30 days of receiving shipment. Certain modification fees, shipping costs, freight charges, and accessories will not be refunded. These exceptions include engraved plaques, all shipping costs, and custom work. Please allow up to 3 weeks for a return check to be sent.
- **4. Technical Support.** Bigeframe will provide technical support for products at no additional charge for 30 days from the date of shipment. Bigeframe provides technical support via email at tech@bigeframe.com. You may also call the sales or tech number listed on our website. Bigeframe may change the means through which it provides technical support at any time. Video help is also available on the website.
- 5. Product Warranty. Bigeframe warrants the original purchaser that the equipment it manufactures will operate for the listed warranty period. This does not cover cosmetic errors such as scratch marks, scuffs, abrasions, dead pixels, or bright pixels on the unit. Bigeframe will repair or replace product, at no cost to the purchaser other than shipping to and from repair location, for the period circled above if the frame stops working properly. This warranty does not apply to those products which have been damaged due to accident, unauthorized alterations, improper repair, modifications, inadequate maintenance and care, or use in any matter for which the product was not originally intended. Travel with the units is not recommended and will not be covered under this warranty. To obtain service under this limited warranty, you must follow Bigeframe's warranty procedures. Please allow up to 30 days for repair and replacement part procurement.
